Swimming Pool Waiver and Release of Liability Form

Release of Liability, Waiver of Claims, Assumption of Risk, and Indemnity Agreement

PLEASE READ CAREFULLY. BY SIGNING THIS DOCUMENT, YOU CHOOSE TO WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE, OF YOURSELF AND/OR YOUR MINOR CHILDREN.

To: Bainbridge Country Club, LLC (“BCC”)

I wish to swim and/or allow my minor children and/or guests to swim at the BCC’s pool facilities. By swimming at the BCC Pool Facility, I recognize and fully understand certain matters, including:

- It is the duty and obligation of the BCC member to properly and safely use the BCC pool facility and the equipment located therein and thereon and to follow all posted BCC Pool Rules at all times and to properly supervise the use of the BCC pool facility and the equipment located therein and thereon by all of the member’s minor children and/or guests at all times and to ensure that their minor children and/or guests use the BCC pool facility properly and safely and follow all posted BCC Pool Rules at all times;
- That all BCC members, their minor children and their guest(s) must sign in at the pool pavilion upon arrival at BCC’s pool facility;
- There is no lifeguard on duty at BCC’s pool facility and that myself, my minor children and my guests all swim at our own risk;
- That persons under the age of fourteen (14) must be accompanied by an adult BCC member at all times;
- That it is my responsibility to watch any minor children and the minor guests who accompany me at BCC’s pool facility closely and to keep them within arm’s reach at all times;
- That diving is not permitted at BCC’s pool facility in pool areas with a depth of five feet or less;
- There is no running permitted in and/or around the BCC pool facility and/or pool deck;
- Swimmers are not allowed to swim alone at any time;
- Glass containers are not permitted in or around the BCC pool facility and/or pool deck;
- There is an Automated External Defibrillator (AED) located on the back wall of the pool pavilion to the left of the door to the “Employees Only” room; and
- 911 should be immediately called in case of an emergency.
- My use of the BCC pool facilities and that of my minor children listed herein below and my guests involves certain risks, including but not limited to:
 1. The risk of injury, including drowning and death, resulting from the inability to swim and/or being a weak or unskilled swimmer;
 2. The risk of injury, including drowning and death, resulting from possible malfunction of the pool equipment;
 3. The risk of injury, including drowning and death, resulting from tripping or falling over obstacles in the pool area;
 4. The risk of injury, including drowning and death, resulting from unsupervised divers and swimmers colliding;
 5. The risk of other injuries, including drowning and death, resulting from participating in any action in the pool.
- I recognize and fully understand that the above list is not a complete or exhaustive list of all possible risks; the list only provides examples of types of risks that I am assuming. In exchange for the BCC allowing myself, my minor children and my guests to utilize the pool and area, I hereby agree to the conditions below.

BCC shall not be responsible for the negligent acts of BCC Members, their minor children and/or guests using the BCC pool facility or the equipment located therein or thereon, or for any injury or death resulting from the use of the BCC pool facility by a BCC member, their minor children and/or their guests.

I fully intend and choose to give up my legal rights and those of my minor children, and to waive, release and indemnify BCC as follows as stated below:

1. TO WAIVE ANY AND ALL CLAIMS, to include but not limited to claims for bodily injury, drowning and/or death, that I or my minor children may have in the future against BCC, its shareholders, its directors, officers, employees, agents, or representatives (hereinafter referred to as the "Releasees") relating to my use and that of my minor children of the BCC pool and pool area;
2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury, expense, or other costs that I may suffer or that my minor children and my/their next of kin may suffer in connection with my use of the BCC pool or pool area to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability to property, or personal injury to, myself, my minor children and/or any guest or third party, resulting from the use of the BCC pool or pool area;
4. That I am over the age of 18 and that I am responsible and will adhere to all the rules of the property;
5. That this Waiver, Release, and Agreement is fully effective and shall be effective and binding upon me and my minor children, and my/their heirs, next of kin, executors, administrators, and assigns, or anyone else authorized to act on my/their behalf or on behalf of my/their estate. I have read and understood this document. I am aware that by signing this document, I am waiving certain legal rights that I and/or my minor children may have against the Releasees, and I fully agree to do so.
